- 📁 4 counties and their First 5 Commissions establish Healthy Kids Healthy Future.

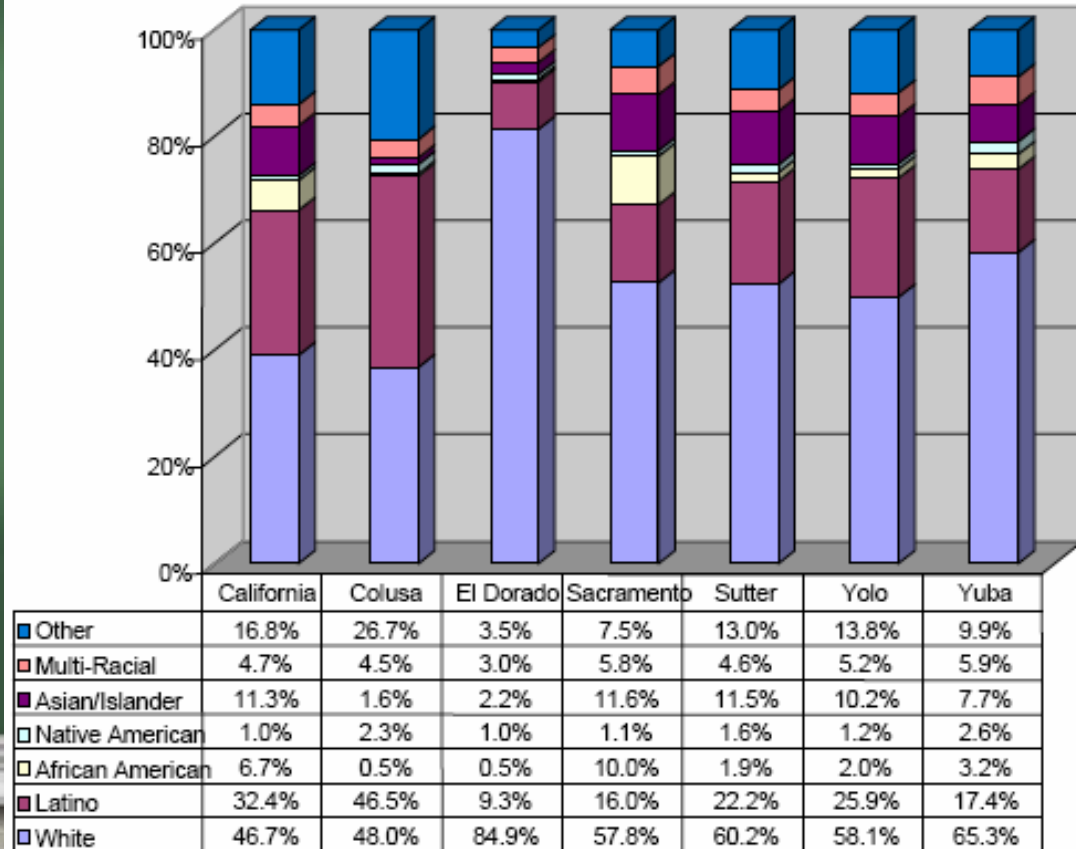


# A Microcosm of California

- 📦 Mix of health care networks and markets

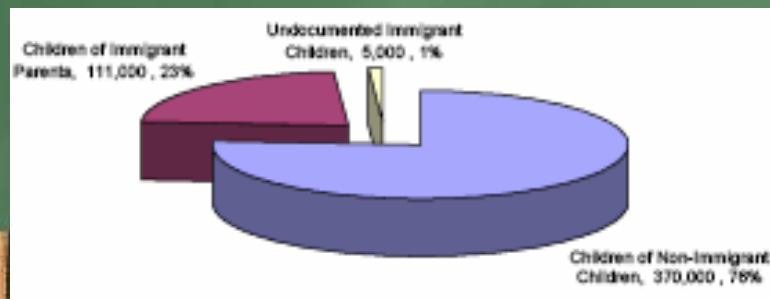
# Diverse Population

Ethnic Composition by County

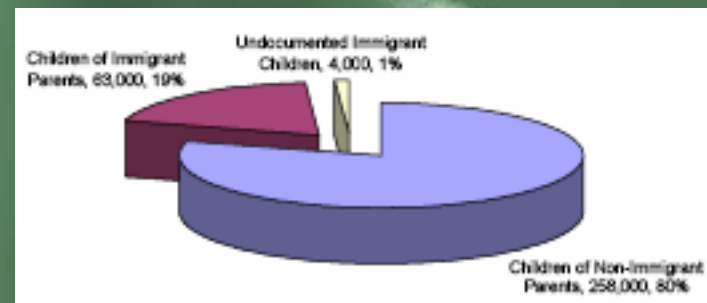


# Children of Immigrants

## Northern Counties

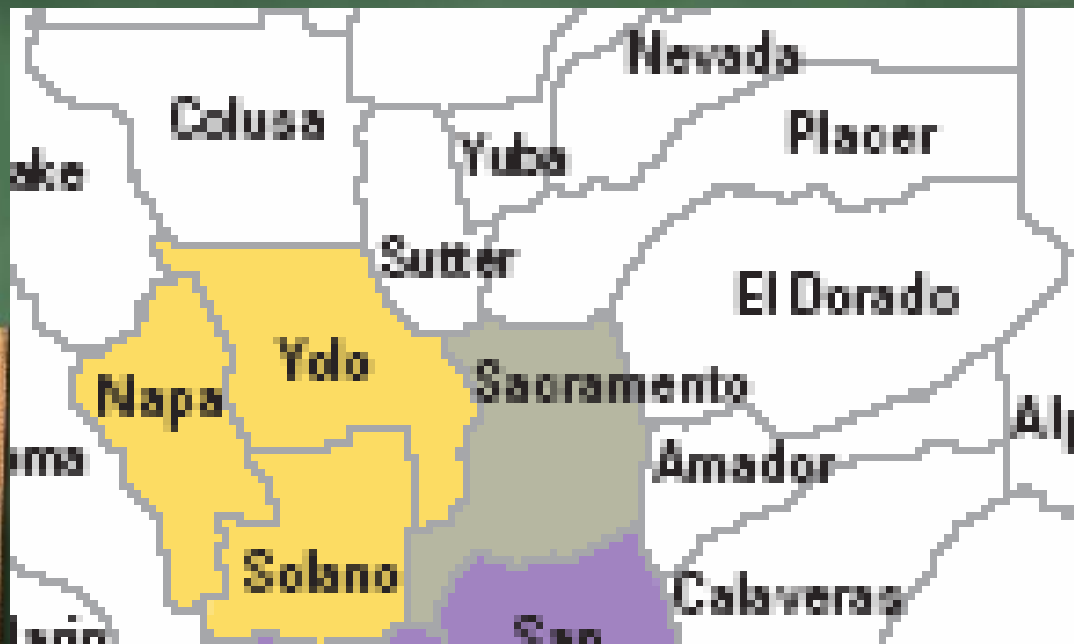

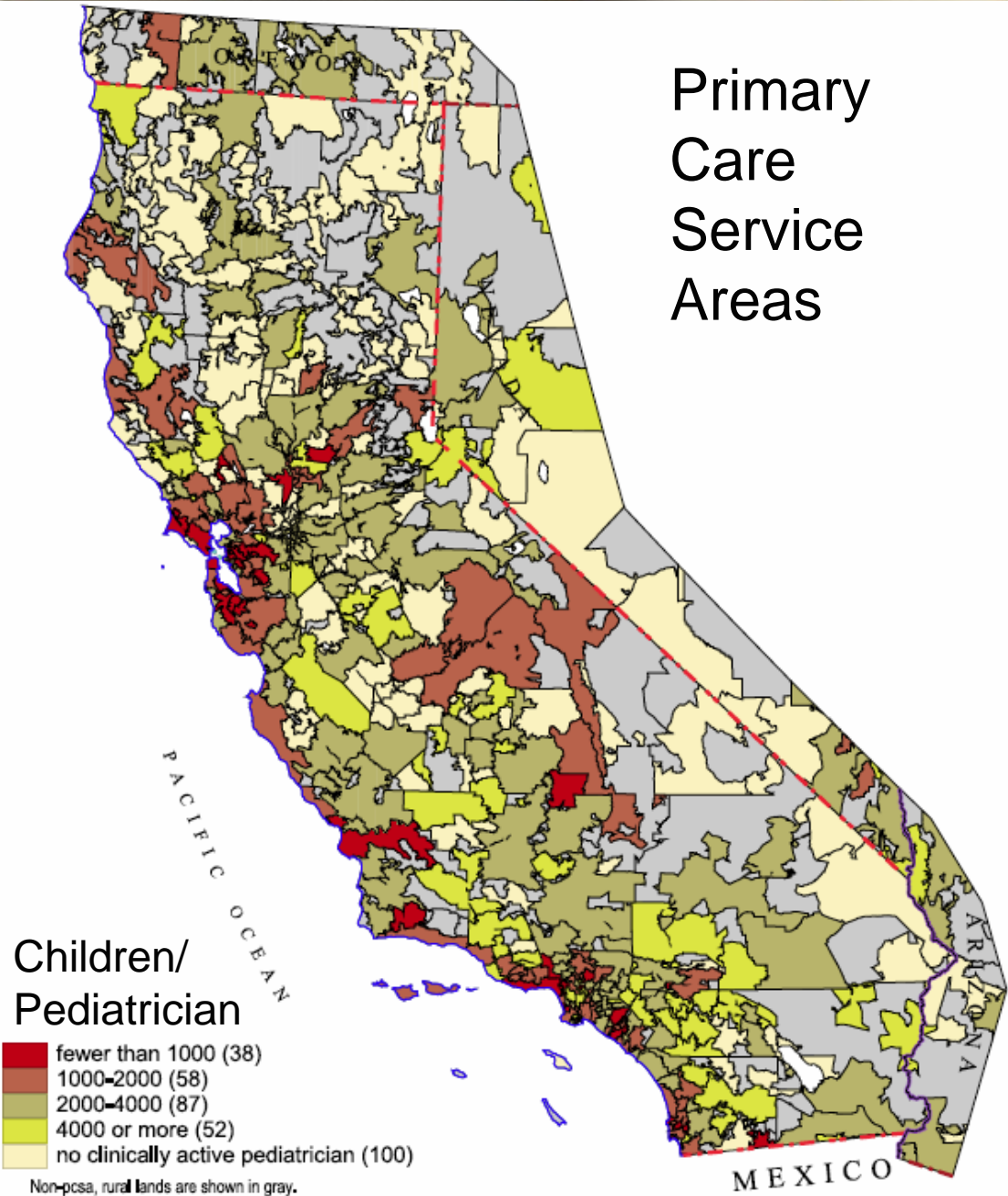
